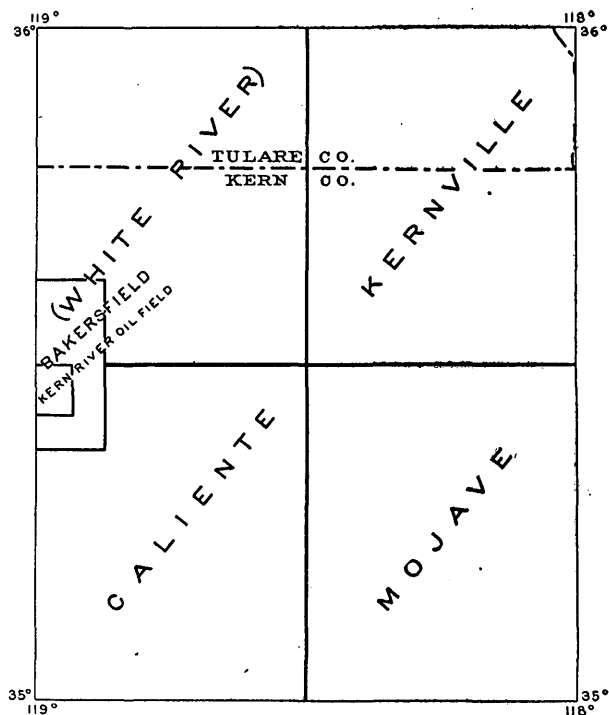


FIGURE 21.—Diagram of degree quadrangle 35°-36°, 118°-119°
