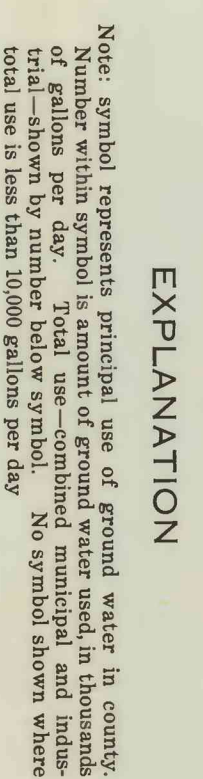


MAP SHOWING AVAILABILITY AND QUALITY OF GROUND WATER

It is noted in table 2 that one or more analyses from each type aquifer indicate that the water analyzed exceeded its maximum acceptable concentration for a given constituent for treated water for public water-supply use.

In general, the ground water of the upper James, York, and Rappahannock River basins is of good quality and suitable for public water supplies (table 3). It should be noted that in most cases where the upper limit of a given chemical element of the raw ground water exceeds the maximum acceptable level for a finished drinking water this excess is found in only one or two water samples.

the 27 counties that make up the province, a wide range of geographical and cultural features are represented and the province's wildlife resources are well illustrated. The book is a valuable reference source and is useful in many areas. Wherever possible, the authors have included the Chinese and Pinyin names of plants, animals and places. The book is a good example of a work of potentially valuable ground research.

Studies of zoogeographical movement to investigate the spread of plant and animal species have been carried out in the Yangtze River basin in the Valley and Ridge physiographic province. The results of these studies have been published in a number of papers (e.g. 1979, 1980, 1981) per year since the 1950s. Therefore, some of the 1166 records of plant and animal species in the 27 counties of the Yangtze River basin have had a valuable use that is different from their original purpose. However, it needs to be pointed out that the records indicate that in the 7 counties that are fully included in this book, the number of records for plants and animals is less than half of the number for the 20 counties that are not included in this book.
