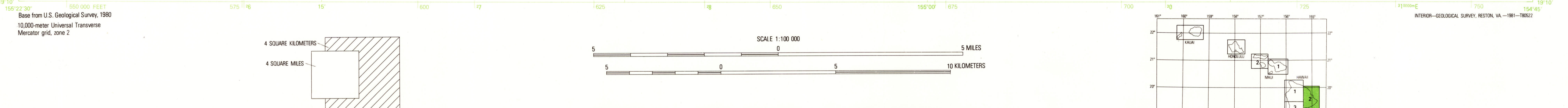

Land use and land cover information compiled from source materials dated 1976-78.

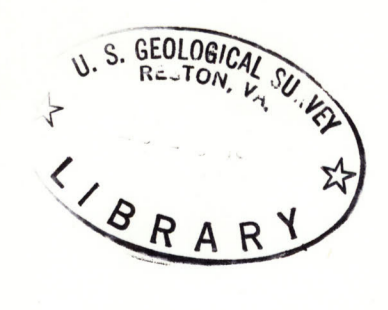
