THE MINERAL INDUSTRY OF LITHUANIA

In 2016, the production of mineral commodities—notably industrial minerals (such as stone and sand and gravel) and mineral fuels (such as peat, crude petroleum, and distilled petroleum products)—represented only a minor part of the economy of Lithuania. The legislative framework for the mineral sector in Lithuania is provided by the Underground Law (law No. I–1034 of 1995) and the Law on Energy (law No. I–828 of 1995 and law No. IX–884 of 2002).

Data on mineral production are in table 1. Table 2 is a list of major mineral industry facilities. More-extensive coverage of the mineral industry of Lithuania can be found in previous editions of the U.S. Geological Survey Minerals Yearbook, volume III, Area Reports—International—Europe and Central Eurasia, which are available at https://www.usgs.gov/centers/nmic/europe-and-central-eurasia.
