THE MINERAL INDUSTRY OF MACEDONIA¹

In 2017 and 2018, the production of mineral commodities—notably copper, iron, lead, lignite, steel, and zinc—represented only a minor part of the economy of Macedonia (table 1; Republic of North Macedonia State Statistical Office, 2019, p. 508–512, 515, 516, 518). The legislative framework for the mineral sector in Macedonia is provided by the Law on Mineral Resources Nos. 136/12, 25/13, 93/13, 44/14, and 160/14 and the Energy Law Nos. 16/11, 136/11, 79/13, 164/13, 41/14, 151/14, and 33/15. Data on mineral production are in table 1. Table 2 is a list of major mineral industry facilities. More-extensive coverage of the mineral industry of Macedonia
