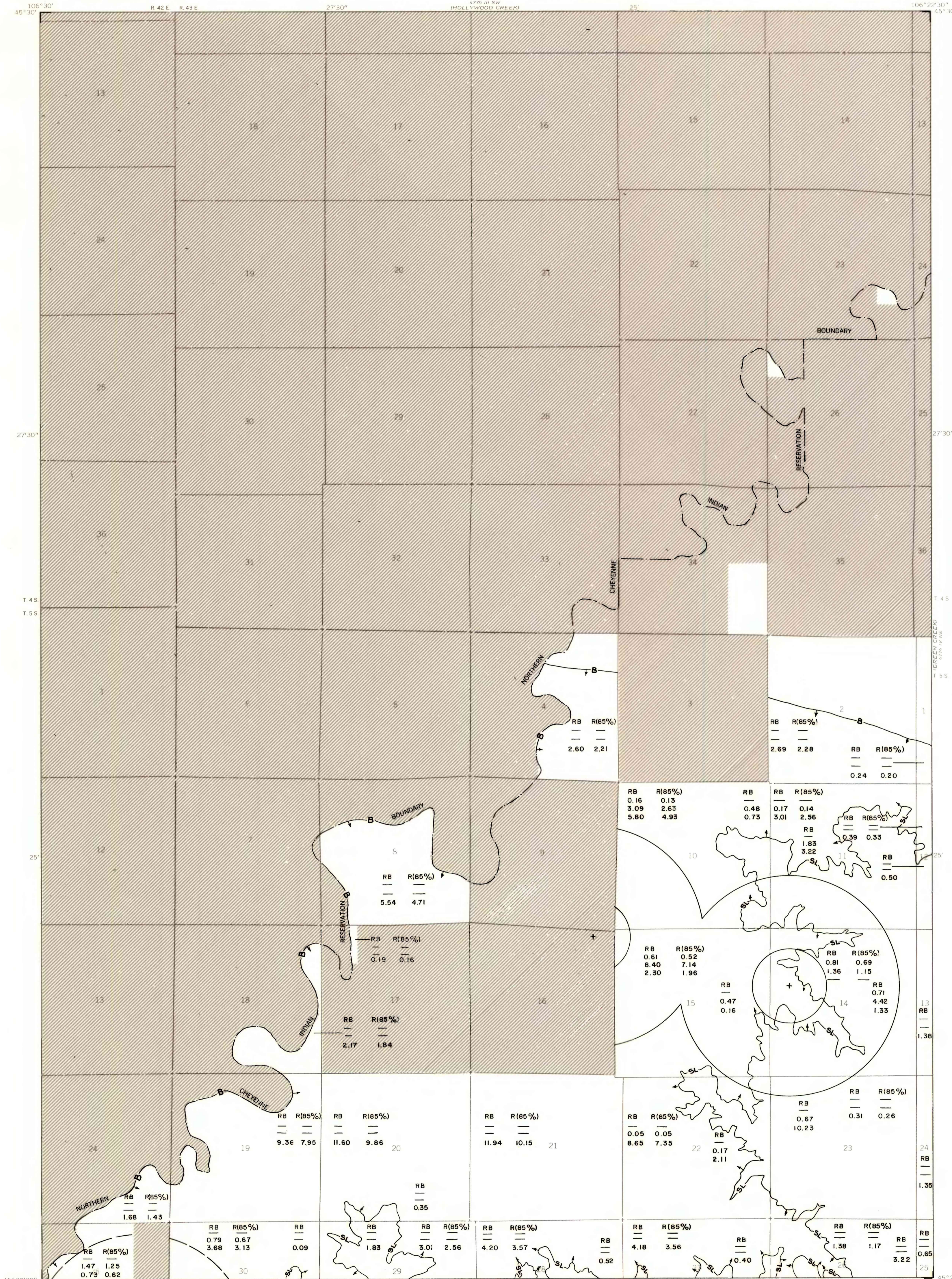

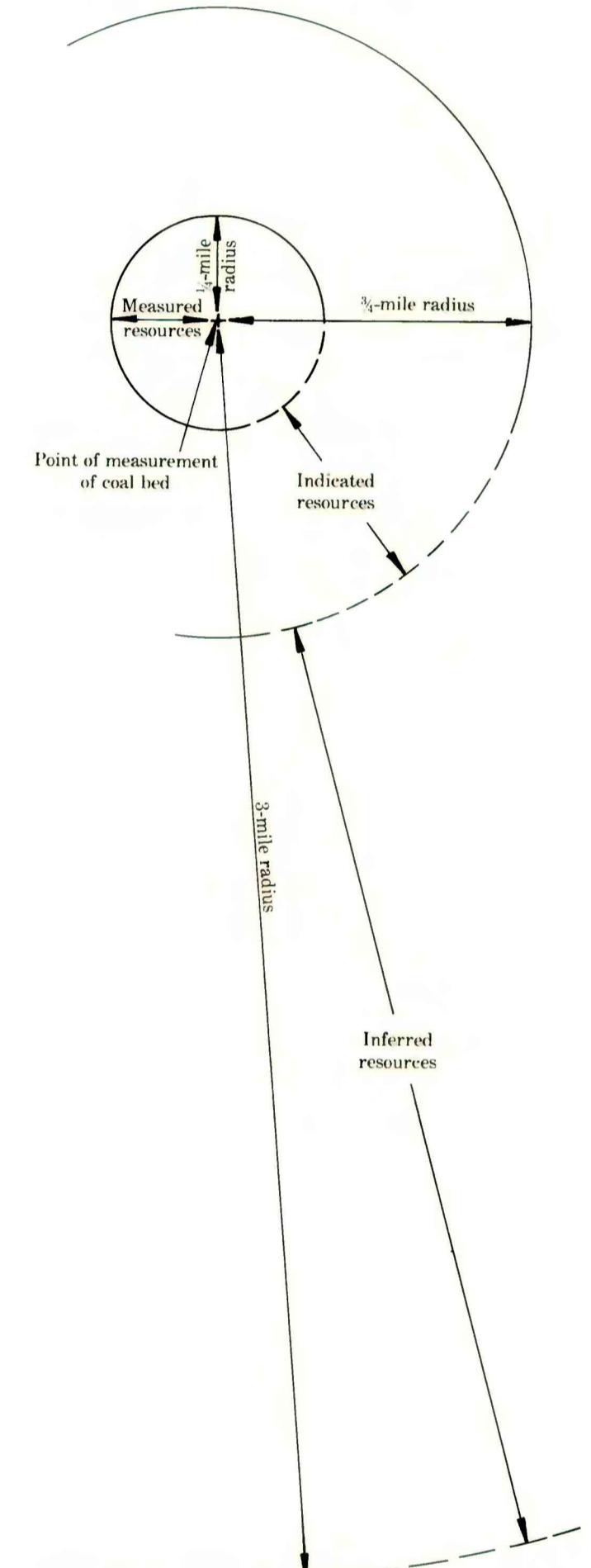

Boundaries of areas are dashed where projected from an adjacent quadrangle. Areas of measured, indicated, or inferred resources may be present on this map without their outer boundaries being shown.

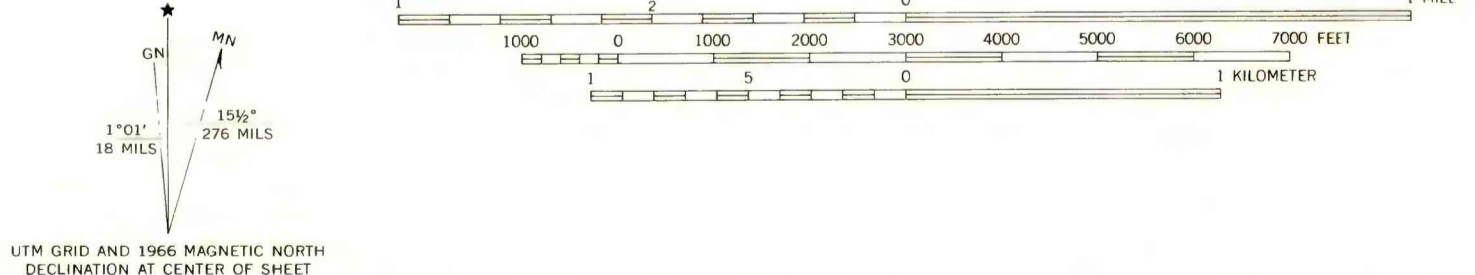
To convert short tons to metric tons, multiply short tons by 0.9072.
