

EXPLANATION

NON-FEDERAL COAL LAND - Land within the KRCA boundary for which the Federal Government does not own the coal rights.

STRIPPING-LIMIT LINE - Boundary for surface mining of the Fruitland 2 coal bed (in this quadrangle, the 200-foot (61-m) overburden isopach). Arrows point toward the area suitable for surface mining. Recovery factor of 85 percent within that area in this quadrangle.

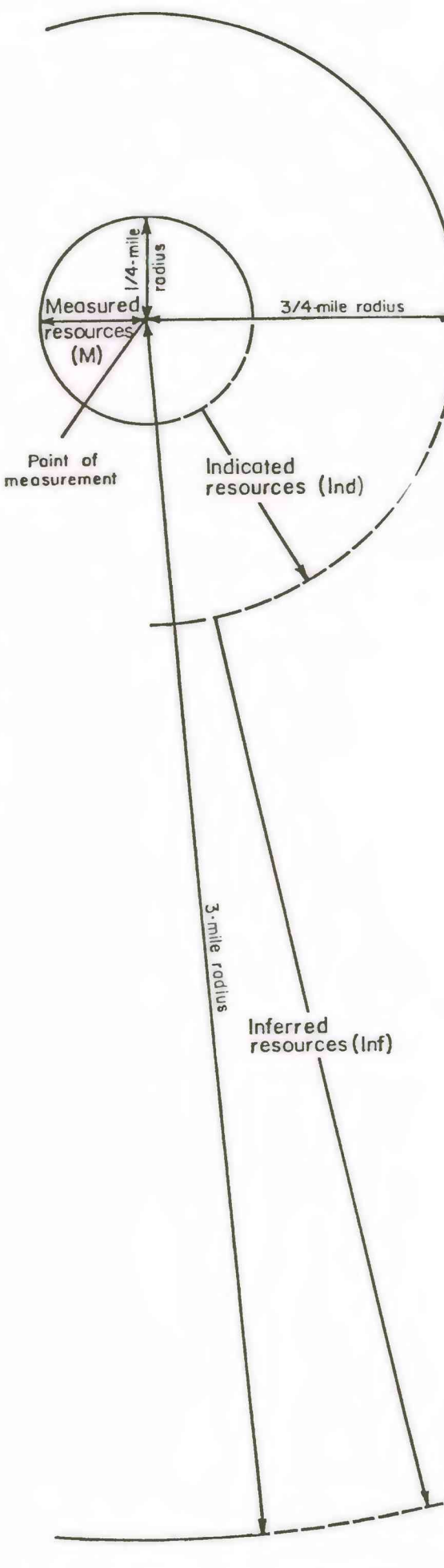
BOUNDARY OF IDENTIFIED RESERVE BASE COAL - Drawn along the coal bed outcrop (O) where the coal is 5 feet (1.5 m) or more thick, the 3-foot (1-m) coal isopach (I), the Federal coal lease (F) and PBLA (P) boundary, and a fault line (L). Arrow points toward area of identified Reserve Base coal.

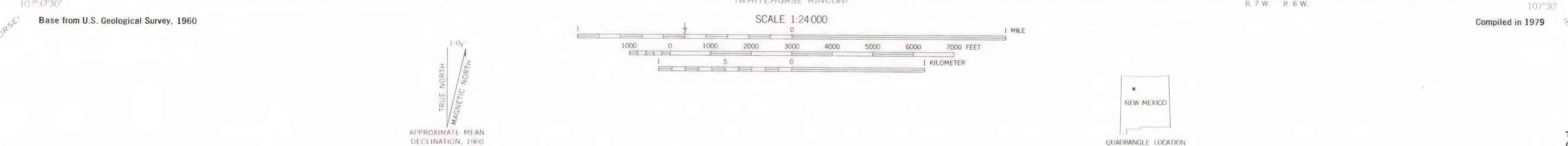


BOUNDARY LINES - Enclosing areas of measured (M), indicated (Ind), and inferred (Inf) coal resources. Dashed where projected from adjacent quadrangles.

To convert short tons to metric tons, multiply short tons by 0.9072.

To convert miles to kilometers, multiply miles by 1.609.

Values given for stripplable and subsurface Reserve (R) tonnages represent 85% and 30%, respectively, of the calculated Reserve Base (RB) values. Calculated Reserve Base and Reserve values have been rounded off to the nearest 10,000 tons of coal.
