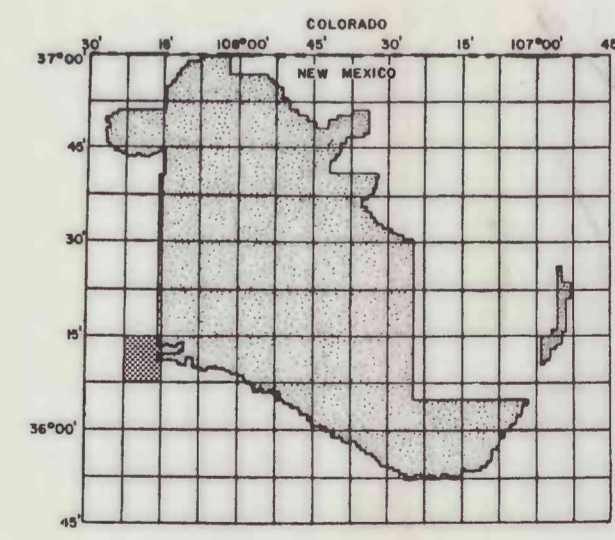
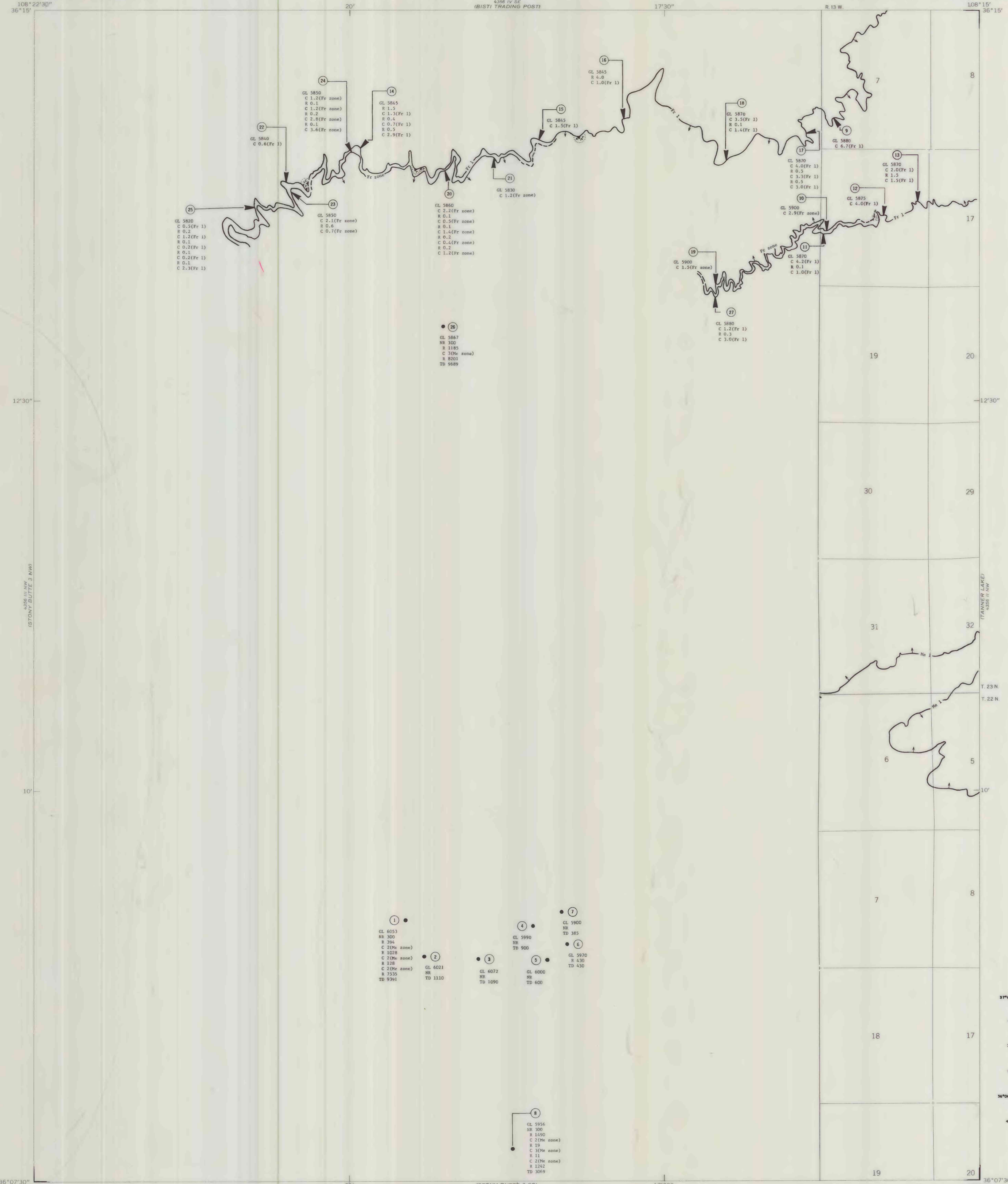

TRACE OF COAL BED OUTCROP - Showing symbol of name of coal bed. Showing rock interval and coal thickness, in feet, measured at triangle. Index number refers to measured section on Plate 3 of CRD map. Arrow points toward the coal-bearing area. Trace of coal bed outcrop modified (from original data source) to fit modern topographic map, dashed where inferred.

BURNED AND CLINKERED COAL - Showing area of baked and fused rock (v symbol). Dotted line indicates inferred limit of burning.

To convert feet to meters, multiply feet by 0.3048.
NR is an average of 300 ft (91 m) of casing. Actual depth of casing not shown.
