RAINFALL IN AND NEAR DU PAGE COUNTY, ILLINOIS, OCTOBER 1991–SEPTEMBER 1995

ABSTRACT

Twenty-four hour rainfall data are presented for 11 rain gages in and near Du Page County, Illinois. Daily rainfall totals were recorded from October 1, 1991, to September 30, 1995. Station descriptions include site identifiers, locations, drainage basins, types of instrumentation, accuracy, and periods of record. Missing and partial rainfall data, and precipitation totals affected by snowfall have been noted for the periods of record.

INTRODUCTION

Du Page County is approximately 17 mi west of the city of Chicago (fig. 1). Rapid urbanization has affected the hydrology in the county. Storm sewers route runoff into wastewater-treatment plants, man-made detention ponds, or streams. Changes in the hydrologic environment have increased the magnitude and frequency of high flows and have resulted in damage to personal and public property. Mitigating flood damages in urban areas is a difficult task for engineers and planners. Hydrologic data are needed to aid engineers and planners in solving stormwater-management and engineering problems related to flooding.

The Du Page County, Department of Environmental Concerns (DCDEC) developed a countywide, comprehensive, stormwater-management plan in response to State legislation and to address flooding problems. The U.S. Geological Survey (USGS), in cooperation with DCDEC, collected rainfall and streamflow data in three small, urban watersheds. These data are used primarily to simulate storm hydrographs and to evaluate a variety of watershed conditions.

Rainfall data collected in and near Du Page County by the USGS from 1986 to 1991 are presented in Duncker and others (1993). Data were collected at 14 stations throughout this period. Data from 11 of those stations were used during the present study.

Purpose and Scope


The purpose of this report is to present daily rainfall totals collected at the 11 rain gages in and near Du Page County, Ill., from October 1, 1991, to September 30, 1995 (present, as defined in this report). For some stations more current rainfall data are available from the USGS. Station descriptions include site identifiers, locations, drainage basins, types of instrumentation, accuracy, and periods of record.

Acknowledgments

The authors acknowledge the staff of the municipal wastewater-treatment facilities and private land owners who permitted installation and continued operation of rain gages on their property.

DESCRIPTION OF STUDY AREA

The study area is in northeastern Illinois 17 mi west of the city of Chicago (fig. 1). The study area includes Du Page County and parts of the surrounding counties. Three tributaries to the Des Plaines River drain most of the study area. The tributaries generally flow south and include the West and East Branches of the Du Page River and Salt Creek (fig. 1).

Physiography

The study area is mostly in the Wheaton Morainal Country of the Region of the Central Lowlands Province (Leighton and others, 1948) (fig. 1). The southwest part of the study area is in the Bloomington Ridged Plain (fig. 1). The morainal ridges were formed in the Wisconsin glacial period and remain the predominant topography. The topography generally is low-lying and poorly drained. Land-surface elevations range from 830 ft above sea level in the northwestern part of the study area to 585 ft above sea level in the southeastern part.

Climate




Figure 2. Locations of National Oceanic and Atmospheric Administration precipitation gages and U.S. Geological Survey rain gages in and near Du Page County, Illinois.

Northeastern Illinois has a temperate, humid, continental climate that is slightly modified by Lake Michigan. Long-term precipitation data in and near the study area are available at National Oceanic and Atmospheric Administration (NOAA) precipitation gages (fig. 2). The long-term average annual precipitation for the study area is approximately 33 in., and the long-term mean annual temperature for the study area is approximately 49°F (U.S. Department of Commerce, National Oceanic and Atmospheric Administration, 1986–91).

METHODS OF STUDY

To describe the spatial and temporal distribution of rainfall in the study area, daily rainfall totals were collected at 11 tipping-bucket rain gages. Data were collected from two stations since February 1986; all stations were installed by October 1, 1990.

Data Collection

Eleven USGS rain gages were in operation throughout the study area (fig. 2, table 1) from October 1, 1991, to September 30, 1995. The location for each station was determined by a distributed spatial coverage and by the selection of sites that were suitable for a rain-gage installation. A consideration used in the determination of site locations was the proximity of existing structures and obstructions. Rainfall data were collected by electronic data loggers in 0.01-in. increments at 5-minute intervals. One rain gage contained a

thermostatically controlled heating element that provides a water equivalent for snowfall.

Data Analysis

Rainfall data were not recorded (missing record) 8 percent of the time during the study period and was attributed to equipment failure and clogging of the rain-gage funnel. Snow-affected data resulted when the rain-gage funnels were filled with snow. Snow-melt readings result as temperatures rise and the snow melts. Snow-melt readings were determined by routine field trips and comparing recorded data with snowfall, snow depth, and temperature and precipitation data from the NOAA precipitation gages (fig. 2). The timing and volume of snow-affected data are subject to appreciable errors and should not be used in modeling.

Small corrections, based on the manufacturer's specifications, were made when the tipping-bucket rain gage under-recorded during periods of intense rain (Qualimetrics, Inc., 1986, p. 8). During intense rainfall, water can spill out of the tipping-bucket without being measured. Over-recording of rainfall at the Sawmill Creek near Lemont, Ill., gage may have resulted from wind vibrating the gage causing the tipping mechanism to tip before it was fully filled. The Sawmill Creek gage vibrates because it is installed on a 10-ft pole. To verify the problem, shaking the gage has been manually reproduced in the field.

RAINFALL DATA

Rainfall data for each station are presented in order of increasing rain-gage station number. A description for each rain-gage station is presented and includes site identifiers, the location of the gage, drainage basins, the type of instrumentation, accuracy, and period of record. Twenty-four hour rainfall totals are tabulated and presented by water year¹. A 24-hour period extends from just past midnight the previous day to midnight the current day. Rainfall totals were not computed for months containing days with missing record. Rainfall data recorded at 5-minute intervals are available for each station from the USGS.

¹The water year is the 12-month period from October 1 through September 30 and is designated by the calendar year in which it ends and includes 9 of the 12 months.

Station number.—05531300

Location.—Latitude 41°53'20", longitude 87°57'41", in NE1/4NE1/4NE1/4 sec.10, T.39 N., R.11 E., Du Page County, on left downstream side of bridge on State Highway 83 in Elmhurst (Elmhurst 7.5-minute quadrangle).

To reach gage.—From north: From intersection of U.S. Highway 90 and State Highway 83, drive south on State Highway 83 approximately 2.5 mi to St. Charles Road. Turn east on St. Charles Road. Proceed approximately 50 ft to Scott Street. Turn south on Scott Street. Park on the west side of Scott Street near the water tower. The gage is located in the open area between Scott Street and State Highway 83, approximately 100 ft west of Scott Street.

From south: From intersection of State Highway 83 and State Highway 56, drive north on State Highway 83 approximately 1.5 mi to St. Charles Road. From the intersection of State Highway 83 and St. Charles Road, follow the directions listed in the previous paragraph.

Drainage basin.—Salt Creek.

Gage.—An 8-in.-diameter, unheated, tipping-bucket rain gage mounted on top of a wooden post approximately 7 ft above the ground surface. A multiparameter electronic data logger, housed inside a weatherproof electrical enclosure and mounted to a wooden shelter near the left downstream wingwall of the bridge on State Highway 83, records rainfall data.

Accuracy.—The rain gage records rainfall totals in 0.01-in. increments at 5-minute intervals.

Period of record.—October 16, 1989, to present. Periods of missing record exist because of equipment-related problems.

To reach gage.—From south: From the intersection of State Highway 83 and Bluff Road, drive west on Bluff Road approximately 0.8 mi to the gate that is across Bluff Road. Rain gage is 750 ft west of the Forest Preserve gate.

From north: From intersection of U.S. Highway 55 and Cass Avenue, drive south on Cass Avenue. Cass Avenue becomes Bailey Road south of the Argonne National Laboratory main entrance. Proceed south to the intersection of Bailey Road and Bluff Road. Turn west and proceed through the Forest Preserve gate. The rain gage is located approximately 750 ft west of the Forest Preserve gate.

Drainage basin.—Sawmill Creek.

Gage.—An 8-in.-diameter, unheated, tipping-bucket rain gage mounted to a steel post, approximately 10 ft above the ground surface. The electronic data logger is housed in a weatherproof electrical enclosure located at the streamflow-gaging site on the upstream side of the bridge on Bluff Road.

Accuracy.—The rain gage records rainfall totals in 0.01-in. increments at 5-minute intervals. Over-recording of rainfall may have resulted from wind vibrating the gage causing the tipping mechanism to tip before it was fully filled. The gage vibrates because of its installation on a 10-ft pole. The vibrating has been manually reproduced in the field.

Period of record.—April 17, 1986, to present. Periods of missing record exist because of equipment-related problems.
