List of Changes for Second Edition

1. Page 2: Revised first paragraph to delete Mud Slough and Colusa Basin Drain at Road 99E near Knights Landing.
2. Page 10: In Table 2, column 4 under the spanner, Sacramento River Basin, replaced the number for item 10 from 61,770 to 61,720. Under the spanner San Joaquin River Basin, in column 2, for items 3 and 4, changed Roads to Road.
3. Page 10: Changed first line of text from [www.srcsd.com/srwtp.html](http://www.srcsd.com/srwtp.html) accessed Oct. 14 to "Sacramento Regional County Sanitation District."
4. Page 15: Replaced figure 8B. STORET data were plotted incorrectly in the first edition.
5. Page 54: Replaced table 7. Loads are in megagrams per month (Mg/mo); flow data were divided by 28 for the month of February and by 31 for the month of May in the calculation of loads.
6. Page 58: Revised paragraphs 3 and 4 to correct numbers and text.
7. Page 59: Replaced table 8. DOC and POC load values were changed for some sites.
8. Pages 60–62: Changed the colors of Mud Slough and Tuolumne River at Modesto to show better contrast in the pie charts.
9. Page 69: Replaced table 9. DOC and POC yields for the Sacramento River Basin sites were recalculated on the basis of new changes in table 7.
10. Page 70: Replaced figure 20A. The Colusa Basin Drain and the Sacramento River at Verona sites were changed to the less than 5 Mg/km<sup>2</sup>/yr DOC yield category.
11. Page 70–71: For figures 20A and 20B, under the Explanation, deleted the parenthetical statement "(excluding Yuba River)" for site no. 4. Also, in the caption, deleted the second sentence that begins "Yields for site 3...."
12. Page 72: Replaced table 10. DOC and POC yields for the San Joaquin River Basin sites were recalculated on the basis of new changes in table 8.
13. Page 73: Replaced figure 21A. The Mud Slough site was changed to the less than 1 Mg/km<sup>2</sup>/yr DOC yield category, and the Merced River site was changed to the 1–2 Mg/km<sup>2</sup> DOC yield category.
14. Page 74. Replaced figure 21B. POC yield category ranges were changed.
15. Page 73–74: For figures 21A and 21B, under the Explanation, added the term "Combined categories" for the last box symbol.
16. Page 77: Added the reference "Sacramento Regional County Sanitation District."
